Report of The Committee of Management

For The Year Ended 30 November 2018

The Committee of Management submit their report together with the financial statements of the society for the year ended 30 November 2018.

Principal Activity and background information

The society operates as St Mirren Independent Supporters Association (SMiSA) and is a nonprofit making concern. It's principal objective is to ensure that St Mirren Football Club Limited remains in the ownership of and is run for the benefit of the community it serves.

The society is registered with the Financial Conduct Authority under the Co-operative and Communities Benefit Societies Act 2014

Results

The surplus for the year was £144,748 (2017 - £156,964) and the reserves at the year end amounted to $\pm 531,339$ (2017 - $\pm 386,591$)

Review and Future Developments

Membership numbers have remained higher than our original estimates and plans. This has allowed us to meet our obligations to the previous shareholders under the Share Purchase Agreement without having to seek external borrowing, as had originally been intended. The final repayment was completed in June 2018.

The focus can now turn to accumulating and safeguarding the necessary funds to complete the purchase of Mr Gordon Scott's shares under the terms of the Shareholders Agreement with him.

Committee of Management

The members of the committee of management, who are all directors of the society for the purposes of company law, who served during the year are as detailed on page 1.

The members have passed the necessary resolution under Section 84 of the Co-operative and Community Benefit Societies Act 2014 to disapply Section 83 of said Act requiring the society to appoint an auditor for the year under review.

1. Accounting policies

1.1 Statement of compliance

The financial statements have been prepared in compliance with the provisions of FRS 102, Section1A, "The Financial Reporting Standard applicable in the UK and Republic of Ireland" subject to the accounting requirements of the Co-operative and Community Benefit Societies Act 2014.

1.2 Basis of preparation

The financial statements have been prepared under the historical cost convention.

The financial statements are prepared in sterling, which is the functional currency of the entity.

1.3 Income

The income of the society represents amounts received from members of the society and amounts raised by the mutual activities undertaken by the members of the society in the year.

1.4. Investments

Investments are valued at cost.

2. Taxation

The society is treated for corporation tax as being mutual trading. It is not generally liable to corporation tax on its revenue surplus except where it has made a profit from activities undertaken other than exclusively with its members.
