The principal objective of the Society is the installation of renewable heating and energy generation measures in places of worship, associated buildings and community buildings.

During the financial year under review, the company started to install the first two developments of solar energy projects at places of worship in Birmingham and the surrounding area.

Under the legislation governing Industrial & Provident Societies, a Society whose turnover is less than £90,000 and whose total assets are less than £2.8 million may, under specified conditions and with the approval of its members, disapply the requirement for a full professional audit of its financial statements. Power for Good Cooperative Limited met the relevant conditions throughout the financial year to 30 September 2015 and the members have not required the Society to obtain an audit of its financial statements for this period.
