Directors' Report for the Period Ended 5th April 2017

The directors present their report and accounts for the period ended 5th April 2017. The accounts have been prepared in accordance with the accounting policies set out in note 1 to the accounts and comply with the society's rules, applicable UK accounting standards, The Co-operative and Community Benefit Societies Act 2014, and the requirements of the Financial Reporting Standard for Smaller Entities (April 2008).

The society has been dormant since it was registered on 29th October 2015. The directors listed above have served as directors throughout the period.

Audit

The members have passed a resolution allowing the society to disapply the requirement to undertake an audit for the period ended 5th April 2017.

Directors' Responsibilities

Law applicable to companies in England and Wales requires the directors to prepare accounts for each financial period, which give a true and fair view of the state of affairs of the society's financial activities during the period and of its financial position at the end of the period. In preparing these accounts the directors are required to:

- select suitable accounting policies and apply them consistently

- state whether applicable accounting standards and statements of recommended practice have been followed
- prepare the accounts on a going concern basis unless it is inappropriate to presume that the society will continue in operational existence
