- (c) Delete final sentence "This Rule cannot be changed without the consent of the Contracted Manager."

2nd line delete "3" and substitute "4"

Final sentence delete full stop after person and replace with ", providing always that Directors elected by and from the Society's Members are in the majority.

Rule 109

Replace with "Unless the Society meets the criteria set out in section 83(2) of the Act or may disapply the audit requirement in accordance with section 84 of the Act, the Board shall in each financial year appoint an Auditor as required by section 83(1) of the Act, to audit the Society's accounts and balance sheet for the year. This provision also applies if the Society is in its first financial year. "
