3.5 Why do you want to ca	ancel the registration of this society?	
The Good Data Cooperative Limited, between 2014 and 2016, developed an open-source technology to gather, process and trade the browsing data of its members. The technology was based on a Chrome browser extension. In 2017 Google rejected The Good Data Cooperative Limited extension from the Chrome Webstore. Since then, The Good Data Cooperative Limited was unable to support members to gain ownership of their browsing data to decide whether to trade it or not for a good cause such as micro-loans to social good projects in Africa. Building a new platform to pursue this objective has been unachievable given the required technical complexity and lack of the sufficient human and financial resources. The directors concluded that this situation will not improve in the foreseeable future. The directors decided that as the objective and mission of the cooperative cannot now be achieved the FCA should be asked to cancel the registration.
