Partial amendment of the rules of Stockport Credit Union

Rule 23, Lines 6 and 7.

Delete the word 'joint'.

After the words 'Board of Directors' delete the words 'and of the supervisory committee.' and insert a full stop.

Rule 63, lines 5, 6 and 7

Delete the sentences 'Any such loan, must be approved by the Credit Committee. The supervisory committee shall be informed of the details of any such loan within 14 days of its approval.' and insert 'The Audit Committee shall be informed of the details of any such loan within 14 days of its approval.'

Rule 83, line 2

Delete the words 'or the Supervisory Committee'

Rule 87, heading

Delete the words 'supervisory committee' and replace with 'Board of Directors'

Rule 87, lines 1 and 2

Delete the words 'supervisory committee' and insert the words 'Board of Directors'

Delete the words 'other than the supervisory committee,'.

Delete the words 'supervisory committee;' and insert 'Audit Committee;'.

Rule 122 Subsection v, lines 1 and 2

Delete the words 'except members of the supervisory committee'.

Rule 122 Subsection w

Rescind the rule.

Rule 123 Subsection g, line 2

Delete the words 'or to the supervisory committee' and insert 'Chair of the Audit Committee'.

Rule 123 Subsection i, line 3

Delete the words 'by the supervisory committee or'.

Rule 128

Delete the Rule in its entirety and insert 'The Credit Committee shall contribute to the monitoring of the Credit Union's loan business. It shall be responsible for any loan assessments referred to it by Credit Union officers. It may also make recommendations on policy changes to the loan and credit control policies for agreement by the Board.'

Rule 129 to 131, headings

Delete heading 'SUPERVISORY COMMITTEE' and replace with 'AUDIT COMMITTEE'

Rule 129

Delete the paragraph and substitute: 'The Credit Union shall have an Audit Committee. Membership of the Audit Committee will consist of a minimum of two independent directors. One director will be elected by the Board of Directors as the Chairperson of the Audit Committee. The Audit Committee, with the permission of the Board of Directors, shall have the power to appoint others as it sees fit and necessary to ensure that it is able to carry out its duties. The Chairman of the Board shall not be a member of the committee. The Audit committee will allow a minimum of two members of the Credit Union to be members of the Audit Committee.'

Rule 130

Delete the paragraph and substitute: 'The Board of Directors shall agree and set the Terms of Reference under which the Audit Committee operates. The Audit Committee will be responsible for monitoring the Credit Union's outsourced internal and external audit functions and regulatory reporting, ensuring that they are performed in accordance with prescribed terms of reference. The Committee will report to the meetings of the Board of Directors and make recommendations to the Board on these matters.'

Rule 131

Delete the paragraph and substitute: 'The Audit Committee will report each year to the annual general meeting.'

Rule 132

Delete the Rule in its entirety and insert 'The Board of Directors may, by a unanimous vote of the entire membership at a special general meeting called for the purpose, suspend from office any Officer of the Credit Union who, in its opinion is guilty of a persistent or serious breach of the law in relation to the Credit Union, these Rules or the policies laid down by the Board of Directors. Whether or not it suspends any Officer, the Board of Directors may by unanimous decision convene a special general meeting of the Credit Union to consider such an action, at which meetings such Officer(s) shall be given an opportunity of state their case and/or be represented.'
