- £3,042 of this represents solicitor's costs for the registration of the Society with the FCA and preparing a number of legal documents relating to secured loans to facilitate investor funding. The balance of £155.90 are costs incurred in purchasing a domain name and hosting for a website.
- The above costs (See Note 1) have been met by income released from the grant funding received from Wiltshire Council and Cricklade Town Council.
- 3 All the assets are held in a Lloyds Bank current account. There is no cash in hand.
- 4 At the end of the financial year the Society had 10 members, all of whom had made the required minimum share subscription of £50.
- The Society has £3,002.10 of restricted reserves, which are the grant awards yet to be spent in accordance with the terms of the grants. This is determined as follows:
