Rule 4,

After Rule 4.6, add the following new paragraph, which shall hereafter be Rule 4.7.

"4.7 promoting and supporting the long term future of the Club which shall include a transaction to sell the entire issued share capital of the Club to new owners resulting in the Society ceasing to own or operate the Club provided that the members have approved the sale by extraordinary resolution (a "**Members Approved Sale**"), and in the event of a Members Approved Sale, the object at this Rule 4.7 shall take precedence and prevail over the objects at Rules 4.1 to 4.6 so that a Members Approved Sale shall be permitted by the Society's objects and be in accordance with the Rules notwithstanding any inconsistency or conflict with the objects at Rules 4.1 to 4.6"



Section 3B – Community benefit societies

3B.1 What is the business of the society? For example, do you provide social housing, run an amateur sports club etc.

Wrexham Football Supporters' Society Limited (the "**Society**") is a society set up by the supporters of the football club Wrexham AFC Limited ("**Wrexham Football Club**") to support and promote Wrexham Football Club.

The Society was formed on 12 March 2002 and acquired the ownership of Wrexham Football Club on 30 November 2011 to save Wrexham Football Club when its previous owners went into administration. Principally, the acquisition was a safeguarding measure until new owners with additional resources were able to take on Wrexham Football Club.

The Society has supported Wrexham Football Club under its ownership and tried to make Wrexham Football Club financially independent and well-run and with the long term aspiration of returning Wrexham Football Club to the Football League.

The business of the Society is therefore to be a custodian and steward for the Club and to seek to preserve the heritage of the Club for the wider benefit of its supporters and the Wrexham community.

After the sale of Wrexham Football Club (as noted in section 3B.6 below), the Society will continue to own WST Assets Limited which holds a 99 year lease of the Racecourse Ground which is Wrexham Football Club's ground. This structure has been put in place deliberately so that instead of winding up the Society following the sale, the Society will continue to safeguard the Racecourse Ground (the oldest international stadium in the world) for the North Wales community. The Society will also continue its activities in support of the community in North Wales.

The Society's ownership has allowed Wrexham Football Club to continue to operate and participate as a football club in in the National League. The Society therefore serves the supporters of Wrexham Football Club, which has a strong local following and heritage.

The Society also organises and runs a number of charitable and fundraising events related to the wider community of Wrexham and Wrexham Football Club's supporters.

3B.4 Does the society work with a specific community, and if so, please describe it here? For instance, are the society's activities confined to a specific location; or to a specific group of people? The society works with the supporters of Wrexham Football Club at the Racecourse Ground to help support the work of named charities (financial and other) who provide valuable assistance to members of the wider community who require their assistance.

3B.5 What does the society do with any surplus or profit? For instance, do you donate the money; does money get reinvested in the business; put into reserves; used for some other purpose?

It is held until expenditure is approved for the good of Wrexham Football Club and the community.

Please tell us how you ensure that any such conflict of interest does not prevent the society from acting for the benefit of the community.

The Society is in negotiations with a corporate entity owned by high profile Hollywood celebrities Rob McElhenney and Ryan Reynolds to sell Wrexham Football Club.

The basis of the proposed transaction is for the new owners to provide significant investment in Wrexham Football Club to secure its long term future and to enable Wrexham Football Club to realise its ambition to return to the Football League and hopefully bring sporting success to the supporters of Wrexham Football Club and the wider community.

It is also noted that Wrexham Football Club has an uncertain future under its current ownership and, whilst the board of the Society are proud of their accomplishments, they consider that Wrexham Football Club is now best served under new ownership and management.

It is further noted that as part of the proposed transaction, the buyer has agreed to give undertakings and commitments to the Society that certain heritage matters relating to Wrexham Football Club will be protected and safeguarded. This is particularly important because the provision of such undertakings and commitments by the buyer evidence and confirm the buyer's intentions to continue to support Wrexham Football Club and the community it serves.

The members of the Society have approved, by extraordinary resolutions, the proposed transaction and the rule changes detailed in this application. The rule change was required in order to permit the proposed transaction under the objects of the Society. Both the sale and the amendments to the rules were approved by an overwhelming majority. Out of the 2018 members of the Society, 89% of the members approved the extraordinary resolutions, and out of the 1846 members who responded to the resolutions (a turnout of 91.5%), the approval was 98%.

Accordingly, the Society does not consider there to be a conflict of interest but wanted to note the above as it is conscious that the partial amendment to the rules to permit the sale of Wrexham Football Club to the buyer is a change of direction for the Society, but a change that has been comprehensively approved by its members on the basis that it is in the best interests of Wrexham Football Club, its supporters and the community it serves.
